# **Administrative Assistant**

### The Duties

- Providing general clerical service which includes correspondences and files handling, backing up the Reception counter and handling general enquiries from hotline when necessary
- Liaising with officers on use of pool vehicles, arranging driver's schedule, car maintenance and documenting relevant records
- Arranging minor purchases, replenishment of office sundries supplies; and overseeing the work of cleaning contractors and security guards
- Managing a petty cash fund, assisting in procurement of goods/services, and other miscellaneous administrative duties
- Arranging simultaneous interpretation / interpretation services, and providing logistics support to EOC events / functions
- Undertaking any other duties as assigned

#### The Person

- Candidates should have Level 2 or above in five subjects including Chinese Language, English Language and Mathematics in the Hong Kong Diploma of Secondary Education Examination (HKDSEE); or Level 2 / Grade E or above in five subjects including Chinese Language, English Language (Syl. B) and Mathematics in the Hong Kong Certificate of Education Examination (HKCEE)
- Proficient in computer software applications, such as MS Office, and word processing skills
- Relevant work experience, preferably gained from statutory bodies, NGOs or sizable public organizations
- Good communication and interpersonal skills; good team player; willingness to learn and take up extra duties; be flexible and able to work under pressure
- General awareness of issues relating to discrimination and equal opportunities; and committed to EOC's vision and mission

[Appointment will be on three-year agreement terms renewable depending on service needs and performance. The remuneration package will consist of a basic salary and a cash allowance in accordance with the Commission's policy. The appointee will also be eligible for a gratuity on completion of the agreement subject to satisfactory performance and conduct.]
