Sri Wahyuni v Lam Yui Sang (林銳生)

DCEO 4/2023

BACKGROUND FACTS

The Claimant, who was employed by the Respondent as a foreign domestic helper, alleged that the Respondent committed unlawful sexual harassment against her on multiple occasions during her 17 days' employment from 17 February 2022 to 5 March 2022.

For instance, on one occasion after taking a shower, the Respondent came up closely to the Claimant and sniffed several times the fragrance from her hair and body and stated that the Claimant smelled nice ("好香"). After this incident, the Claimant immediately put herself on guard whenever interacting with the Respondent and took covert audio recordings to protect herself.

The Claimant's covert audio recording captured the following sexual advances made by the Respondent, including:

- 「好多人都有老公架喇,好多人都結咗婚架啦,咁都會有感情架,都會同第二個男人有感情架。」(Translation: Many people have husbands. Many people are married. They would still have feelings and would also have feelings for another man.)
- 2. 「我想搵到個好嘅工人姐姐同我生一個仔,同我結婚,同我生個仔我係咁樣想嘅…」 (Translation: I want to find a good domestic helper to give birth to a son for me. Marry me and give birth to a son for me. This is what I want.)
- 3. 「我話我喜歡你,你話你唔喜歡我咪算囉!」 (Translation: I say I like you. You say you don't like me. Then just leave it like that.)
- 4. 「諗都諗到我要啲咩啦吓話,孤男寡女喺度。」(Translation: You can think what I want. Only single man and woman here.)
- 5. 「你肯嚟我呢度返工做嘢,諗都諗到係想,想同你發生關係架啦,你又唔係,你又唔係未結婚, 30 幾歲人喇,諗都諗到吓嘛···見到你好靚,你個樣好靚呀。」(Translation: You came to work for me. You can think that I wanted to have a relationship with you. You are not...you are not unmarried. You are over 30 years old and can think. I find you attractive and you have a pretty face.)
- 6. 「[答辯人之前聘請的外籍女傭] 肯同我搞嗰啲嘢嘛,佢肯嘅,即係畀啲錢佢肯嘅。嗰陣時佢 23 歲,佢肯架。即係畀啲錢佢肯嘅。」 (Translation: [The previous foreign domestic helper employed by the Respondent] was willing to mess around with me. She was willing to do that. I gave her some money and she was willing to do so. At that time she was 23 years old. She was willing to do so. I gave her some money and she was willing.)

On another occasion, the Respondent suggested giving HK\$600 to the Claimant in return for sex with him. The Claimant clearly and firmly rejected each of the Respondent's above unwanted sexual advances and/or requests for sexual favours.

On 5 March 2022, after a serious dispute with the Respondent, the Claimant called the Police out of fear for her own safety and moved out from the Respondent's residence with the assistance of the employment agency.

The Claimant lodged a complaint with the EOC. The EOC's legal team represented the Claimant in bringing legal proceedings against the Respondent at the District Court under the Sex Discrimination Ordinance (SDO).

COURT'S DECISION

The Court found that there was a clear case of sexual harassment under the SDO. The Court awarded damages to the Claimant for injury to feelings, loss of earnings, and exemplary damages as follows:

Injury to Feelings: HK\$60,000 Loss of Earnings: HK\$112,387.30 Exemplary Damages: HK\$10,000
